**La Center Arts Council**, the "Licensee" (individually the "Party" and collectively the "Parties").

### In Consideration of

The Licensee paying the License Fee to the Licensor, the receipt of which is hereby acknowledged, the Licensor grants the usage rights to the Licensee on the following terms:

### Licensed Intellectual Property

1. The Licensor retains ownership of the original artwork and is granting the right to use the following licensed Intellectual Property:

### Grant of License

2. The Licensor grants to the Licensee a non-exclusive license to use the Intellectual Property indefinitely.
3. The Licensee will pay by check the Licensor a License Fee in the lump sum of \$50.00 due upon the selection of the licensor's illustration.

### Permitted Use

4. The Licensee is permitted to use the Intellectual Property for the City of La Center's Trail Project, including promotional materials such as internet, posters, and note cards. This use does not include the right to sell or distribute the original Intellectual Property.
5. The Licensee may modify the Intellectual Property without prior approval and will be the owner of any derivative works created by the Licensee while using the Intellectual Property.
6. The Licensee shall not falsely represent that they are the original creator of the Intellectual Property, and the Licensor will be credited in every instance.

### Assignment

7. The Licensee shall not allow others to use the Intellectual Property and shall not use the Intellectual Property in a way that allows others to use the Intellectual property except in accordance with this Agreement.

8. The Licensee may not assign or transfer the Agreement or any rights granted within it, without the prior written consent of the Licensors, and any attempted assignment or delegation without such consent will be void.

#### **Termination**

9. The Licensors reserves the right to discontinue the license and terminate the Agreement immediately if any copyright infringement has taken place due to the Licensee's unauthorized use of the Intellectual Property.

#### **License-Back**

10. The Licensee grants to the Licensors the non-exclusive right to use, during the Term of this Agreement, any derivative works created by the Licensee using the Intellectual Property.

#### **Confidentiality**

11. Any Confidential Information exchanged between the Parties will not be shared or disclosed to any person except with prior, written consent of the other Party, or as required by law.
12. Confidential information refers to any data or information relating to the Party, whether business or personal, which would reasonably be considered to be private or proprietary to the Party and that is not generally known and where the release of that confidential information could reasonably be expected to cause harm to the Party, and includes trade secrets, moral rights, goodwill, copyrights, patents, trademarks, know-how, research, drawings, plans, designs, standards, specifications, and methods.
13. Confidential Information does not include information that is generally available to the public.

#### **Dispute Resolution**

14. If any dispute to this Agreement between the Licensors and the Licensee is not resolved through informal discussion within 14 days from the date a dispute arises, the Parties agree to submit the issue first before a non-binding mediator and to an arbitrator in the event that mediation fails. The decision of the arbiter will be binding on the Parties. Any mediator or arbiter must be a neutral party acceptable to both Licensors and Licensee. The cost of any mediations or arbitrations will be shared equally by the Parties.

#### **General Provisions**

15. This Agreement constitutes the entire agreement between the Licensors and the Licensee with respect to the subject matter hereof and there are no further items or provisions, either oral or otherwise.
16. This Agreement may be executed in counterparts. Facsimile and digital signatures are binding and are considered as original signatures.
